#### **2025** Pawnee Business Council Inauguration

Pawnee Reserve, Oklahoma, (May 15, 2025)-The Pawnee Business Council (PBC) celebrated the 2025 PBC Inauguration at 10:00 a.m. on May 17, 2025. The event took place at the PN Multipurpose Building located at 808 Morris Rd. in Pawnee, Oklahoma.

Four members were honored in the inaugural celebration: Vice President, Jordan D. Kanuho, Secretary, George Gardipe, Member Seat # 3, Carol L. Nuttle, and Member Seat # 4, Jenifer Gover Littlesun.

Kanuho and Gardipe serve as re-elected officials, while Nuttle and Gover Littlesun are now both newly elected officials.



The agenda included Welcoming Remarks by the new Executive Director, Mr. Virgil Wade. The 2025-2026 Pawnee Nation Princess, Cora Pratt "Sku" (on that Good Road), gave the invocation by performing the Lord's Prayer in Native sign language. Mr. Wade then introduced our Madame President, Misty M. Nuttle. President Nuttle welcomed everyone and congratulated the returning Council Members and the newly elected Council Members. She conducted the Oath of offices for all four members.



Next, Mr. Wade introduced 2nd Čawî' Rêsâru' and Paktiku (Camp Crier) Arthur Fields IV "Kûruks Rahastawiku" (Bear Tied Up) greeted everyone in attendance and and explained his role as Paktiku (Camp Crier), he then performed his duty by announcing the newly sworn in Council Members to all of our akitâru' as well as all of the creations.

Mr. Wade then turned the Inauguration over to the Cultural Resource Division Director, Herb Adson "Tikûruks Râhikûcu" (The Brave Bear), who rendered a Pawnee Prayer Song to conclude the Inauguration.













Gilbert Beard, 1st Resaru for the Ckiri Band, commented,



"I was happy to attend the Inauguration Ceremony, alongside the rest of the Nasharo Council, and witness the inauguration of the returning Council Members and the newly elected Council Members. Our Nation is fortunate to have many great leaders amongst our people who are willing to serve our akitâru' wholeheartedly. The Inauguration itself was outstanding; it was very well put together and I applaud everyone who was behind the scenes who made it all happen. One thing that really stood out to me, was it also showcased something that really sets us (Čahriksičahriks/Čahiksičahiks) apart from the neighboring tribes around us, OUR CULTURE."

#### The Nasharo Council Band Meeting and Elections were held on

May 3, 2025

The Chaui Band Meeting was held at the Museum of the Pawnee Nation (657 Harrison St.).

The Pitahawirata Band Meeting was held at the Law Enforcement Conference Room (1200 Heritage Circle).

The Skidi Band Meeting was held at the PNC Albin LeadingFox Building (861 Little Dee Dr).

The Kitkehahki Band Meeting was held at the Pawnee Earthlodge (829 Little Dee Drive).

#### Head Kitkehahki Chief Morgan LittleSun

"It was brief, we met in frontof the boy's dorm. We had breakfast burritos, donuts, coffee, and orange juice. We opened with the prayer and accepted nominations for Head Chief.

The Band voted for me to remain in my position as Head Chief.

Next, we accepted nominations for 2nd Chief. Pete Moore and Adrian SpottedHorseChief were nominated. The Band chose to keep Adrian in his current position as 2nd Chief as well.

We concluded and thank everyone for their attendance and participation."

#### **Head Pitahawirata Chief Frank Adson**

"Nawa Akitaru,

A scheduled Pitahawirata Band meeting was set in accordance to the Pawnee Nation Constitution. The meeting was held on Saturday, May 3, 2025, at the Pawnee Nation Police Department Conference Room.

As 1st Resaru of the Pitahawirata's Reminders were put out on the PN website and Facebook to attend respective band meeting for selection of band chiefs.

Currently, Frank Adson - 1st Resaru and Tim Jim - 2nd Resaru have served the previous term and now have been elected again by acclimation.

The nomination for 1st Resaru was raised by a band member. it was seconded as well. Band members raised the nominations to cease and continue with our current Resarus by acclimation, all in attendence agreed.

Suggestions to have regular Band meetings were discussed. We will try and use the Fall and Spring Dances held and sponsored by the Pawnee Business Council and Resaru Council. Time and place TBD."

## Head Skidi Chief Gilbert S. Beard

"We opened with welcoming words. Rîsâru' Pat rendered a prayer and breakfast was served.

While the folks were finishing their meal, I gave some opening remarks, welcoming everyone and I thanked them for allowing me to serve them as Head Rîsâru' of the Band. I also shared some thoughts concerning the Selection of Chiefs.

2nd Skidi Rîsâru Pat LeadingFox also gave opening remarks and thanked the Band for allowing him to serve the Band as 2nd Rîsâru'. He also shared thoughts with the Band about the Selection of Chiefs.

We opened the meeting up for Nominations of Head Skidi Rîsâru' and 2nd Rîsâru'. The Band chose to keep both Rîsâru' Pat and I in our current positions.

Both Pat and I thanked the Band for their trust and support in our leadership.

Next Rîsâru' Pat and I spoke to the Band concerning our culture and lifeways. After our discussion, we opened it up to the Band for any remarks. Many of our Band members shared words of encouragement with Rîsâru' Pat and I. After everyone had their chance to speak we concluded with a prayer and dismissed.

Ati'as Tirawâhat kistîwata Ckiri akitâru', nawa! (Our Father in the Heavens, watch over the Skidi Band, amen!)"

## **Head Chaui Chief Matt Reed**

"Jordan Kanuho began with a prayer.

I cooked a meal for the band and David contributed with fry bread and drinks. We had boiled buffalo roast, beef roast, blue corn hominy and pork, blue corn hominy with pumpkin and Anasazi beans, apple and cherry cobblers, and boiled potatoes.

Before we voted, I reminded everyone that potential chiefs had to be enrolled in the Nation.

After everyone was served and we were close to done eating, I asked them for their nominations for head chief. They selected me unanimously.

David then asked to speak and he informed everyone that he could no longer serve.

I asked for nominations for 2nd chief and they nominated Arthur Fields IV "Kûruks Rahastawiku" (Bear Tied Up). He was selected unanimously. There were 23 people in attendence no including myself."

#### **Mad Bear Plaque Presentation**

Pawnee Reserve, Okla. (May 30, 2025) - The Museum of the Pawnee Nation, the Pawnee Nation Tribal Historice Preservation Office (PNTHPO), and the National Guard Casuality Operations Office held an honoring ceremony at the City of Pawnee Cemetary where the Pawnee Scouts Memorial stands.

The ceremony began with a cedar blessing (Allen Moore). Gilbert S. Beard, Ckiri Rîsâru, Nasharo Council, emceed the ceremony while other speakers included: Cultural Division Director Herb Adson and Ty Burns (Oklahoma State Representative Dristrict 35).

Burns retired from the 45th Infantry Brigade with 20 years of service in 2018. Sgt 1st Class Burns has been deployed to Iraq in 2007-2008 and Afghanistan in 2011-2012. He is the recipient of many awards including Combat Infantry Badge, Bronze Star, and Purple Heart.

According to the Pawnee Nation Tribal Historic Preservation Officer, Joseph "Matt" Reed, "This is to mark the installation of the Medal of Honor headstone for Mad Bear, which should have been installed 112 years ago with his funeral. At all of our Pawnee Nation cemeteries you will find the graves of veterans of the Pawnee Scout Battalion with no military headstone despite having served honorably in the United States Army."

The Pawnee Princess, Cora Pratt, and Pawnee Indian Veterans Organization Homecoming Princess Isabelle Leading Fox unveiled the Military Medal of Honor Gave Marker.

Pawnee Reserve, Oklahoma, (May 5, 2025)-The Pawnee Nation partnered with Ascension Recovery Services to host the official Grand Opening of the 22,000-square-foot, 26 bed adult/geriatric inpatient and outpatient behavioral health and substance use disorder treatment facility, Pawnee Nation Behavioral Health.



Adrian Spottedhorsechief, 2nd Resaru for the Kitkehahki Band, led the ceremony. The newly crowned 2025-2026 Pawnee Nation Princess, Cora Pratt, was designated for the invocation and beautifully performed the Lord's Prayer. Welcoming remarks were presented by Madame President Nuttle of the Pawnee Business Council. The Proj-ect Introduction was given by Brian Kirk (Program Manager) while Gilbert Beard, 1st Resaru, delivered a Pawnee Song. Guest speakers included Kendall Carter, Vice President/Owner of Thompson Construction Inc (TCI), Dwayne Robinett, Senior VP, Managing Principal of HFG Architecture, and Doug Leech, Founder & CEO of Ascension Recovery Services.

According to Baker Tilly, "The Pawnee Nation of Oklahoma partnered with Ascension Recovery Services, an industry leader in developing comprehensive, fully integrated behavioral health systems for vulnerable populations who are uninsured or underinsured, to design the facility's welcoming, accommodating programming, tailored for the ethnically diverse Tribal community that has not historically had access to treatment."





The facility also provides local, accessible treatment for the predominately rural five-county service area, including both native and non-native members, who previously were forced to travel more than 40 miles to Tulsa to seek quality behavioral and mental health treatment.





GoGo married his wife, Yvette, in Wichita Falls, Texas. Together, they made their home in Anadarko for over 25 years. 

He began his journey on January 11, 1955, at Ponca City, Oklahoma, the son of Clifford B. Shilling, Sr. and Elsie Taylor Shilling. While it is difficult to capture the essence of a man in a few lines from an obituary, maybe you can note some trends and draw your own conclusions. As a toddler, Rob's eating preferences were, at best, questionable. His favorite snacks were raw potatoes and raw hotdogs. Despite his odd food cravings he thrived and attended Liberty Elementary School where he met and made life long friends among his fellow students and favorite teachers-Mrs. Stumbaugh, Mr. Wright and Mrs. Howell.

While at Liberty he also discovered the sport of football and his passion for raw potatoes and raw hotdogs was replaced by the post-game Lotaburger. Despite his changing and expanding palate his love of football remained throughout his life. He would play for West Jr. High and then out on the hill he played on the line for the Ponca City Wildcats where he would learn many valuable lie lessons under the tutelage of his coach, Jerry Runyan. Rob's attitude was once a Wildcat always a Wildcat.

During his senior year the Wildcats defeated their arch enemy and Super Bowl. Rob left the familiar environs of Ponca City to further his education at Stanford University. While at this bastion of enlightenment the streaking phenomenon was racing across college campuses nation wide. Rob's dorm decided to streak the Golden Gate Bridge as the Bay Are Runners Extraordinaire, Association of Stanford Students (the acronym being BARE ASS.) Rush hour traffic was brought to a standstill while the San Francisco television stations and newspapers covered the event. Rob's picture, along with his derby hat and smile, made the front page of the San Francisco Chronicle along with a bevy of his fellow streakers. When his mother saw the picture she immediately recognized his bare bottom. We were impressed but she said she knew his cheeks instantly because she had powdered and diapered them and a mother doesn't forget. Rob then relocated to Norman, Oklahoma, to attend the University of Oklahoma where he pledged a fraternity noted for its intramural football prowess. They practiced hard, partied too much, occasionally attended class and won the school championship. Needing additional money, Rob became a waiter at Legend's, an upscale Norman bistro, with an all greek wait staff, where he acquired a taste for eggs Benedict and bloody Marys. Always eager for the next adventure Rob chucked the frat life and became a bartender at O'Connell's Irish Pub when it was the place to be in Norman.

He also acquired the Pub's top secret chili recipe which, unfortunately, he takes to the grave. From the Pub he went to work for Santa Fe Rail Railroad and became a union man when he joined the Brotherhood of Maintenance of Way Employes as a gandy dancer, a steel-driving John Henry job, where he swung a spike maul to drive spikes into the railway ties. He laid track from Kansas to Texas. From his time on the railroad steel gang Rob became a connoisseur of greasy spoon blue plate specials and spicy Mexican vegetable soup brought north of the Rio Grande by Mexican Railway workers.

From Santa Fe Railroad he returned to Ponca City, and now being a committed union man, joined the Oil, Chemical and Atomic Workers Union. In short fashion he worked his way up from the yard at Conoco Refinery to operator trainee and became a customer of the chicken fried steak at Cobbs Cafe. An operator at the refinery was a dream job but Rob's wanderlust was not yet abated and he joined the Navy to see the world. He had always lived like a sailor in port, so in many ways he was just legitimizing his lifestyle. He was a blue water sailor who explored the world of the southwest Pacific and many Asian ports of call. He was a navigator with the rank of Petty Officer 1st Class. He would spend nine years in the Navy and discover that he loved the sea.

He acquired a dragon tattoo in Hong Kong and expanded his epicurean bent with sushi in Japan, kimchee in Korea and meat on a stick in the Philippines. A highlight of Rob's naval career was the invasion of Russia. In the fall of 1983 Russia shot down a Korean Airliner. Rob was on a Rescue and Salvage ship that was part of a task force sent to look for the airliner's black box. The admiral in charge of the task force called all ship's captains to a meeting on the flagship. During the meeting Rob continued to plot his ship's location because they were immediately adjacent to Russian territorial waters. He discovered that due to currents and wind they were quickly drifting toward Russian waters. He informed the navigation officer who told him he must have made a mistake because the flagship would not allow them to get so

close to Russian waters. It turns out the flagship chose that moment to perform navigation equipment maintenance and the task force was, in deed, drifting into Russian waters. Suddenly Russian frigates and destroyers were swarming the area and loud speakers informed the task force that it was in Russian waters and should prepare to be boarded. The task force beat a hasty retreat to international waters and would live to fight another day. Because Rob did truly love the sea he next signed up to become a mate on a merchant ship but fate intervened and he went home to Oklahoma to help his father who was experiencing health issues. Rob entered the next phase of his life as a logger in southeast Oklahoma where he enjoyed catfish and venison back stran and almost anything fried.

Logging is hard work and Rob was getting a little long in the tooth he looked around for a profession that rudn't e., Pose him to the elements and hard, heavy lifting. He found the program in Radiologic Technology. After training at Meridian Technology Center he became a registered Rad Tech at hospitals in Stillwater, Cushing and Antlers, eventually becoming Director of the Radiology Department at Pushmataha County Hospital in Antlers. Rob was still employed there when he was called home. Rob was predeceased by his parents; his nephew, Allen Hensley; and his niece, Kimberley Oldham. He is surnved by his brother and sister-in-law, Clifford Shilling, Jr. and Jamie Childs Shilling; his adopted sisters, the Fabulous Baker Girls, Kim DeHaven and Kristy Rogers; nephews, Taylor Shilling and Brennon Hensley; nieces, CreCre Oldham, Mahiya Shilling Mesa and Helen Paige Opper; great nieces, Ruby and Violet Hensley; and great nephew, Ramon Wesley Taylor Mesa; and many beloved cousins and extended family members from the Taylor, Little Eagle and Shilling families. Rob was an enrolled member of the Pawnee Nation and also of Choctaw heritage. His Pawnee name is Kuruks Takab, which translates to White Bear.

Rob was a member of the Kitkehahki Band and also of Skidi descent. He is a direct descendant of Pawnee Chief White Eagle and renowned Pawnee Scout, Arusa To-tah-it, Robert Taylor. His grandparents are: William Columbus Shilling and Mary Jane Kelly Shilling; Jobie Taylor; Paul Little Eagle and Julia Murie Little Eagle. When Rob stopped traveling the world he proudly served as Vice President of the Pawnee Indian Veterans Association. He was also the worlds best uncle. He took nieces and nephews to many events over the past thirty years ranging from innumerable circuses, to the U.S. Open Tennis Championships, the Toronto International Film Festival, major league baseball games, the OU-Texas game, Paul McCartney, the Rolling Stones, Pawnee Indian Veterans Doings, church (both Baptist and Methodist) and much more. He has entertained us aU with his stories of the sea. A better man could not have died and we will miss him dearly.
